## Program Details (#38LAA):

---

- A retail lease through GMAC for qualified buyers that aligns payments with those available through our Corporate Employee Lease Program
- All Chrysler salaried Retirees/Surviving Spouses are eligible for 2 retail leases under this program. Only the retiree or spouse is eligible.
- Lease term: 36 months/15,000 miles per year (incremental mileage can be purchased)

✓ **ELIGIBLE VEHICLES/RETIREES**

ALL 2010 Model Year Chrysler, Jeep, Dodge and Ram vehicles. All Chrysler salaried Retirees/Surviving Spouses are eligible for 2 retail leases under this program. Only the retiree or spouse is eligible. Lessee is responsible for Insurance, Tax, Title & Registration.

✓ **SCHEDULED AND RECOMMENDED MAINTENANCE**

- 6,000 mile service intervals. Includes most scheduled and recommended maintenance services as outlined in the owner's manual
- 3,000 mile Lubrication, Oil and Oil Filter change service.  
Dealer cap allowance for LOF service: \$30

✓ **\$100 "SIGN-AND-GO" TOWING AND ROADSIDE ASSISTANCE**

Plan provides 24-hour "Sign-And-Go" Towing and Roadside Assistance (up to \$100 per occurrence). Benefits include towing, flat tire change (with your good spare), battery jump, out-of-gas fuel delivery (2 gallon maximum), and lockout service (i.e., keys locked in vehicle or frozen lock). Towing assistance will be dispatched only for mechanical disablement which renders the vehicle inoperative.

✓ **FIRST DAY RENTAL**

Plan provides a \$35 allowance for First Day Car Rental for any dealership mechanical repair or maintenance service. Excludes bodywork.

✓ **LOANER VEHICLE ALLOWANCE**

Plan will provide a loaner vehicle (5-day maximum per occurrence) for any overnight dealership mechanical repairs.

✓ **\$1,000 TRIP INTERRUPTION PROTECTION**

The Plan will pay up to \$1,000 for lodging, meals and car rental expenses if ...  
1) the vehicle is inoperable due to component failure covered by the factory warranty  
2) and the failure occurs more than 100 miles from home.

✓ **TRANSFER POLICY**

Plan is non-transferable and non-cancellable.

## COMPARISON TO THE FORMER COMPANY CAR LEASE PROGRAM

Below is a monthly payment comparison. Actual monthly payments will vary with specific models and equipment. The payment differential will be less after Insurance, Tax, Title & Registration are added, but we believe the result will still be competitive.
