*IRS regulation (IRS Notice 2006-110) requires proper documentation for each contribution to a charity made after Aug. 17, 2006. Prior law also called for "reliable" written proof. The difference now is that the IRS is being specific about the documents it requires. Proof of all donations is now needed for all contribution levels.

Employees who contribute through payroll deduction, and choose to claim a tax deduction, must have:



1. A pay stub, W2, or other employer document showing the total amount withheld for the charity,
AND
2. A copy of the pledge card or duplicate, or a letter from the organization in order to claim a tax deduction.

Note: Employee/retirees that contribute by check must have either a cancelled check or other bank record, or proper written acknowledgement from the charity.

If you are interested in contributing, simply:

1. Print and complete both sections of this form, keep the top portion for your income tax record
